

# TERMS & CONDITIONS

## REGISTER TO WIN COMPETITION – GAME OF SKILL

### Eligibility

1. Information on “How to Enter” and Prize details form part of these Terms and Conditions of Entry (“Conditions”). Submission of an entry constitutes acceptance of these Conditions. Entries not completed in accordance with these Conditions will be ineligible.
2. Entry is only open to Australian residents currently residing in Australia who are aged 18 years or over. Entrants must submit an entry in accordance with these Terms and Conditions.
3. Employees, directors and/or officers (and their immediate family members and members of their households) of the Promoter or of its subsidiaries or related companies or agencies associated with the Competition, are ineligible to participate. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

### Definition

4. For the purposes of these Terms and Conditions, the following definitions apply:

  - b) **Prize** and **Prizes** means the items that comprise the Prize Pool.
  - c) **Competition** means Register to Win Competition being run during the Competition Period.
  - d) **Competition Period** means the period commencing at 12:01am (Sydney time) on 1 June 2021 and ending at 11.59pm (Sydney time) on 30 December 2021.

### Entry and Verification

5. During the Competition Period, the Promoter will operate a webpage at <https://www.lg.com/au/register-your-product> where a competition question will be posted.

To enter, the Entrant must:

- a) Visit the web page at <https://www.lg.com/au/register-your-product>;
  - b) complete the online form by providing their full name, email address and contact number;
  - c) answer the competition question, “*Tell us in 25 words or less, how your LG product makes your everyday that bit better?*”;
  - d) login into an existing myLG account or sign up for a new myLG account; and
  - e) register at least one LG product by selecting your LG product from the drop down list (by entering the Model Number or selecting by Product Category) and filling out the product registration form.
6. One entry per person is permitted.
  7. Entries will not be valid if the judging panel deems their content to be inappropriate, disrespectful or offensive.

8. Entries are deemed to be received at the time of receipt by the Promoter. The Promoter is not responsible for receipt of incorrect, inaccurate or incomplete information caused by an entrant or occurring during transmission. The Promoter is not responsible for any problems or technical malfunction of any telephone, telephone or computer network, or lines, servers, or telephone or internet providers, traffic congestion on any phone or computer network, or any combination thereof, including any injury or damage to participants or any other person's handset or computer related to or resulting from participation or sending or receiving of any communication or of any materials in this Competition.
9. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

### **Judging & Prize**

10. The winners will be the best seven valid entries submitted during the Competition Period as judged by the judging panel, having regard to skill, creativity and originality. Judging will take place at LG Electronics Australia, 2 Wonderland Drive, Eastern Creek at 5pm on the following dates, based on the best valid entry submitted to date:

  - Friday 31 December 2021
11. Winners will be notified via email or phone call within two weeks after judging takes place and be asked to confirm their contact details and provide their delivery address. The judge's decision will be final and no correspondence will be entered into.
12. This is a game of skill and chance plays no part in determining the winner. All valid entries will be individually judged according to their skill, originality and creative merit and the entry judged to be the best will win the Prize. All entrants must submit only their own original answers and answers cannot be previously published in any forum worldwide.
13. There will be 7 (seven) winner(s) in total. Each of the 7 (seven) best eligible entries will receive one out of the seven Prizes from the Prize Pool (each valued at RRP \$3,499). The Promoter may select additional reserve entries and record them in the case of an invalid entry or ineligible entrant being drawn.

### **Promoter's Rights and Liabilities**

Each entrant warrants to the Promoter that each entry submitted is an original artistic work of the entrant that does not infringe the rights of any third party. The entrant agrees to indemnify the Promoter against all costs and claims by third parties arising from a breach of this warranty. Entrants consent to any use of their entry which may otherwise infringe their moral rights pursuant to the Copyright Act 1968 (Cth).
25. Entrants agree that they are fully responsible for the content of the entry they submit (Content). The Promoter shall not be liable in any way for such Content to the full extent permitted by law. Entrants warrant and agree that: (a) they will not submit any Content that is unlawful or fraudulent, or that the Promoter may deem in breach of any intellectual property, privacy, publicity or other rights, defamatory, obscene, derogatory, pornographic, sexually inappropriate, violent, abusive, harassing, threatening, objectionable with respect to race, religion, origin or gender or otherwise unsuitable for publication; (b) they will obtain full prior consent from any person who has jointly created or has any rights in the Content, to the uses and terms herein; (c) their Content shall not contain viruses or cause injury or harm to any person or entity; and (d) they will comply with all applicable laws and regulations, including without limitation, those governing copyright, content, defamation, privacy, publicity and the access or use of others' computer or communication systems. Without limiting any other terms herein, the entrant indemnifies the Promoter and the Promoter reserves the right, in its absolute discretion, to reject entries for any breach of the above terms.
26. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury, or any loss or damage (including indirect or consequential loss) which is suffered or sustained in connection with this Competition or taking or utilizing any goods/services offer as a prize, including but not limited to, where arising out of the following: (a) any theft, unauthorised access or third party interference; (b) any entry that is late, lost, altered, damaged or misdirected (whether or not after receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (c) any variation in the offer value to that stated in these Conditions; (d) use of the prize; (e) any equipment malfunction or programming malfunction, or for any technical error, or any combination thereof that may occur in the course of the administration of this Competition including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, technical problems or traffic congestion on the internet or website,

software failure (f) any injury or damage to entrant's or any other person's computer related to or resulting from participating in or downloading any materials in the Competition.

27. Certain legislation implies guarantees or conditions or imposes obligations upon the Promoter which cannot be excluded, restricted or modified or cannot be excluded, restricted or modified except to a limited extent. These Terms and Conditions do not exclude or limit the application of any statutory provision where to do so would contravene that statute or a cause any part of these Conditions to be void.
28. In the event of war, terrorism, state of emergency or disaster, the Promoter reserves the right to cancel, terminate, modify or suspend the Competition subject to any written directions from a relevant Regulatory Authority.
29. The Promoter collects personal information about entrants to include entrants in the promotion, and for direct marketing and publicity purposes. If the personal information requested is not provided, the entrant may not be eligible to participate in the promotion or LG may not be able to award the Prize. By participating in the promotion, the entrant consents to the use of their personal information for the purposes disclosed above, which will involve storage of their personal information on the Promoter's database and expressly consents to the Promoter using the information for future promotional, marketing and publicity purposes including contacting entrant in the future with information on special offers or provide entrant with marketing materials via any medium including mail, telephone and commercial electronic messages (SMS (Short Message Service), MMS (Multimedia Message Service), IM (Instant Messaging) and email) or any other form of electronic, emerging, digital or conventional communications channel whether existing now or in the future. The Promoter may also share the personal information collected with its related companies overseas and the entrant consents to the use and disclosure of their personal information to any such overseas entities. Entrants can also gain access to, update, correct or destroy any personal information, make a complaint about a breach of privacy, or opt out of receiving any communications by contacting the Promoter at the address below.

By entering the Competition, each entrant agrees to the Promoter using their entry, name or image for printing, broadcast, publicity, commercial and promotional purposes without compensation and agrees to granting the Promoter a perpetual and non-exclusive license to use any such material in all media worldwide (including but not limited to TV, web, radio, catalogue, press, and point of sale) and agrees not to object to any such use on the basis of any moral right.
33. If an entrant does not provide the Promoter with all the information requested on the entry form, the entry form will be invalid.
34. If for any reason this Competition is not capable of running as planned, whether caused by infection by computer virus, mobile phone failure, line drop out, bugs, tampering, unauthorised intervention, fraud, technical failures or any other cause beyond the control of the Promoter which corrupt or affect the administration, security, fairness or integrity of the Competition, the Promoter reserves the right in its sole discretion, (subject to any written direction given by a relevant Regulatory Authority), to cancel, terminate, modify or suspend the Competition. The Promoter may in its sole discretion disqualify any individual who tampers with the entry process.
