Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“**SEBI Listing Regulations**”), we wish to inform that based on the recommendation of the Nomination and Remuneration Committee, the Board of Directors of the Company, at its meeting held on **November 27, 2025**, has approved an internal Re-organisation of the roles and responsibilities of its Senior Management Personnel (“**SMP**”) in line with the Company’s organizational requirements and governance practices, effective from November 27, 2025.

The internal Re-organisation of the roles of certain employees of the Company has resulted in changes to their reporting structure.
