RE: Your e-mail dated January 27, 2025, to the Securities and Exchange Board of India ("SEBI"), LG Electronics India Limited (the "Company") and the BRLMs ("Complaint No. 3") in relation to the draft red herring prospectus dated December 6; 2024 ("DRHP") filed by Company for the initial public offering of equity shares of the Company ("Offer")

Dear Mr. Singh,

This is in relation to Complaint No. 3, alleging misrepresentation and omission in the DRHP. At the outset, we deny allegations made by you in Complaint No. 3, including omission to disclose details of litigation in the DRHP. Please note that the disclosures in the DRHP, including in relation to outstanding litigations involving the Company, its Directors, and its Promoter, have been made in accordance with the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended ("SEBI ICDR Regulations") and other applicable laws.

We note that the allegations made in Complaint No. 3 are similar to those in your previous complaints dated December 21, 2024 bearing reference number SEBIE/KK24/BENG/047110/1 filed on SEBI Complaint Redressal System platform ("SCORES"), along with your email dated December 23, 2024, to SEBI and BRLMs ("Complaint No. 1"), and your email dated January 15, 2025, to SEBI and the BRLMs ("Complaint No. 2", along with Complaint No.1 and Complaint No.3, the "Complaints"), for which we have already provided our paragraph wise detailed response through our response dated January 23, 2025 ("Response"). We request you to kindly refer to our Response where we have provided detailed responses to each of the litigation matters mentioned in the Complaint No.1 and 2.

We note that in Complaint No. 3 you have also referred to an additional matter, response to which is provided in Annexure A below.

All capitalized terms not defined herein shall have the meaning ascribed to such terms in the DRHP.
