LG Electronics MobileComm U.S.A., Inc. ("LG" or "Sponsor") is offering a limited time promotional offer for the purchase of a new LG V30 or new V30+ device ("Qualifying Product") at participating carriers or authorized retailers (Authorized Retailer/Carrier). Subject to the terms and conditions of the Promotion, all LG V30 or V30+ Device Purchases must be made Thursday, November 16, 2017 through Saturday, December 2, 2017 ("Promotion Period"). Participants who purchase a new LG V30 or new V30+ during the Promotion Period and one (1) additional qualifying LG product from LG's mobile, home electronics, or home appliance ("Second LG Product") product lines sold at an Authorized Retailer/Carrier within forty-five (45) days of Device Purchase or by January 16, 2018, **whichever is sooner**, and successfully complete the Online Submission, as outlined below, will receive one (1) prepaid VISA® card equal to the amount of the purchase price of the second LG product up to \$400 not including any sales tax or shipping fees. ("prepaid VISA card"). Available while supplies last. Please allow 6-8 weeks for fulfillment of valid promotion requests for the prepaid VISA card.

SUBMISSION PROCESS:

Online Submission: Participants must wait fifteen (15) days after date of the purchase of the Qualifying Product before submitting a claim.
